I understand that any sums that I pre-pay in anticipation of my acceptance as a member of the SJFOM (e.g., pre-payment of dues) shall not guarantee my membership in the SJFOM and any pre-paid sums shall be returned to me in full if my application for membership is denied. Dues for the period of February 1, 2024 through January 31, 2025 shall be \$250.00 (Fools) or \$200 (Jewels). Further, I agree, accept and acknowledge that if my membership application is approved by the SJFOM, then the following provisions shall be the contractual provisions of my membership in the SJFOM. I hereby agree to and accept the following provisions as contractual and I hereby expressly agree to abide by and be bound by the following contractual membership provisions, to-wit:

In and for the consideration of fee(s) paid and my acceptance to participate in the St. John Fools of Misrule ("SJFOM") events during the period stated above, I hereby agree to abide by all present and future rules, bylaws, and policies of the SJFOM whether known or unknown by me and any and all instruction(s) or directive(s) issued to me by any officer and/or representative of the SJFOM. I further agree to unconditionally waive any and all liability I have or may have against SJFOM, its officers, council, board, directors, members, agents, employees, insurers, sureties, indemnitors, successors, subcontractors, and any other related parties and entities and hereby fully and unconditionally release, acquit, discharge, indemnify, covenant not to sue, and forever hold harmless the SJFOM, its officers, council, board, directors, members, agents, employees, insurers, sureties, indemnitors, successors, subcontractors, and any other related parties and entities, from any and all actions of whatever kind or nature, causes of action, past, present or future claims, injuries, and damages, known or unknown, anticipated or unanticipated. I agree that I personally assume any and all risks, foreseeable or not, associated with my participation and/or attendance at any function involving this organization. I agree that I shall not invite or bring any other guest or non-member to any function of the SJFOM without said guest or non-member executing a written Release and Waiver of Liability agreement prior to the event and the express consent of the Council of Unreason. I agree that it is my duty to obtain said Release and Waiver of Liability form from a member of the Council and return the original executed copy prior to the event. I agree that any breach of this contract or violation of the rules, bylaws, or policies of the SJFOM, whether known or unknown to me, or my failure or refusal to follow the instruction(s) or directive(s) of the Council or any officer and/or representative of the SJFOM at any time shall result in my expulsion and physical removal from any event and/or membership and forfeiture of all sums previously paid to the SJFOM with no right of refund. I specifically agree that if I am expelled from any event or from membership, irrespective of the location of my expulsion, it is my sole responsibility, including financial, to arrange my transportation back to the point of origin or to any other destination I desire. I agree that the Council (or its official designee) shall have complete and sole discretion and authority to determine if I have breached this contract or violated any rule, bylaw, or policy of the SJFOM and that the Council has authority to make any decision it deems fit. The Council's decision is controlling and final. I also agree that I have no right to a hearing, due process, or appeal regarding my participation or expulsion from any SJFOM event and/or membership whether any event is officially sanctioned by the SJFOM or not. I agree that the SJFOM has my full authority to use my likeness including but not limited to photograph, video, voice and/or any other form, in any form or manner obtained from my participation in SJFOM and/or at any time for any purpose in any form with my absolute waiver of any compensation for said use. I hereby specifically and unconditionally waive, release, covenant not to sue and forever discharge SJFOM, its officers, council, board, directors, members, agents, employees, insurers, sureties, indemnitors, successors, subcontractors, and any other related parties and entities regarding any and all liability of any kind or nature, claims in negligence or otherwise. In the event of any claim, lawsuit, or dispute concerning this contract, my participation in any event or otherwise, and/or the SJFOM, its officers, council, board, directors, members, agents, employees, insurers, sureties, indemnitors, successors, subcontractors, and any other related parties and entities, I agree to first submit any such disputes or disagreements to mediation in St. Tammany Parish, Louisiana prior to initiating any legal action, lawsuit, or claim and I shall pay the mediator's fees and costs as well as respective costs and attorney fees for said mediation. Venue for all lawsuits, claims, and disputes of any kind between me and the SJFOM, its officers, council, board, directors, members, staff, agents, employees, insurers, sureties, indemnitors, successors, and subcontractors, concerning this agreement in any way, or my participation in SJFOM shall be in the 22nd Judicial District Court for the Parish of St. Tammany, State of Louisiana. I acknowledge and agree that I was provided a copy of this document with ample time to review its terms prior to my signing. I acknowledge and agree that I have read this agreement in its entirety and I freely and voluntarily accept, agree to and understand the terms and conditions set forth herein. I agree that there are no other terms or agreements existing, oral or written. I agree that this contract cannot be amended or modified in any way without the authorized written consent of the SJFOM. Further, this contract supersedes, novates, overrides and controls any prior contract(s) I have or may have with the SJFOM.

By signing below, I acknowledge that:

- Everyone is required to wear an approved costume and mask at the 12th night party and street march.
- There will be no admittance to pre- or post-party or street march without an approved costume and mask.
- Removal of mask will result in immediate expulsion from this event.
- Failure to RSVP to events by the stated deadline might lead to a fine or cancelation of my right to attend the event.
